## **The Human Resource Development Policy**

The Company delivers a business concept base on integrity, discipline, and a good perception of staff and workers by supporting and promoting employees' expertise, personal competency, working skill, good motivation, and health consciousness. In addition, the Company provokes diligence and perseverance, job indulgence, and self and social responsibility. Therefore, the Company effort following the human resource management guideline to accomplish the goals as follows;

1. Every employee is treated fairly, equally, and gratefully.
2. The Company must operate impartially regarding employment, compensation, training, resignation, and retirement of employees by considering ethnicity, caste, nationality, religion, disability, gender, sexual discrimination, union membership, and political affiliation.  
The career path and job position are determined by education qualification, competency, experience, health, and other requirements for a particular job position.
3. The Company disallows forced labor, such as detention, and is confined by concerned documentation. Employment of children under 15 years old is prohibited. Employees who have not become their legal ages are not allowed to work in the workplace and outside under hazardous, risky, and unsanitary conditions
4. The Company does not allow the employee to act in sexual harassment, even by eyesight and physical character. It also involves sexual threatening, coercion, and force for other benefits.
5. The Company provides workplaces with safe, hygienic, and sanitary conditions, such as drinking water, toilet, etc. The Company set up a procedure to prevent accidental incidents and health injuries in the workplace. Further, a training program for such is regularly set up, and a scheme to research and detect the possible safety hazards and health injuries is managed to avoid the incidence.
6. The Company trusts that good communication in the workplace could enhance work efficiency and good interrelationship; therefore, the Company provides the proper communication channel to an employee on appropriate occasions.
